Methodology of Review: Retrospective Review to identify regulations in need of being modified, strengthened or eliminated. Framework included the elements of statute authorizing the rule, mission of protecting the public through nursing regulation, redundancy, outmoded, excessively burdensome and mitigation of agency discretion. During the retrospective review process, regulatory restrictive language in accordance with Executive Order 2020-03, will decrease by 31 per cent (from 528 restrictive words to 366 restrictive words) with promulgation of the proposed rule revisions/deletions.
